After his military service, he enlisted with the Cleveland Police Department, where he served from 1950-1975. He worked several years with the Cleveland Police Intelligence Unit, and knew and worked with my father, Inspector Walter Davenport, who served the CPD from June 1939 thru June 1977. He has been Past President and very active in the Retired Police, Fire, and Widows Organization of Greater Cleveland & Cuyahoga County.

Bro. Clarence Albert Watters was raised in Bigelow Lodge #243 on June 26, 1951, 60+ years of faithful Masonic service. He demitted to Halcyon #498 in 1994, and then affiliated with John W.
